Pursuant to Regulation 30 of Listing Regulations, we would like to inform you that, Board of Directors of the Company at its meeting held on May 24, 2025, inter alia, has considered and decided the following matter:

Considered and approved the conversion of 7,25,000 warrants out of 10,00,000 warrants allotted to Satiny Constructions Limited into 7,25,000 Equity shares of face value of ₹ 2/- each out of the warrants allotted on January 31, 2025 on Preferential Basis to allottees of Promoter & Non-Promoter Group.

Further the special resolution passed by the shareholders of the company in the general meeting dated January 07, 2025 and in-principle approval received from BSE Limited ("BSE") on January 29, 2025 vide letter no. LOD/PREF/MV/FIP/1756/2024-25.
