Considered and approved the conversion of 7,25,000 warrants out of 10,00,000 warrants allotted to Satiny Constructions Limited into 7,25,000 Equity shares of face value of ₹ 2/- each out of the warrants allotted on January 31, 2025 on Preferential Basis to allottes of Promoter & Non-Promoter Group.
